

## 2026 NCBA League Participation Agreement – Renewal (Registration NLT June 1, 2025)

This League Participation Agreement (“Agreement”) is by and between the Undersigned College or University Club Baseball Team (“Team”) and the National Club Baseball Association (“NCBA”).

The undersigned Team hereby agrees to participate in the 2025/2026 NCBA season upon the terms and conditions of this agreement. The undersigned Team will be placed in Division I, Division II, or Division III by the NCBA. The undersigned Team’s division placement will be the same as the previous season unless the undersigned Team has auto-qualified per the NCBA rulebook to be moved up or down a division; OR unless the undersigned team requests to move divisions and is agreed upon by the NCBA; OR the NCBA requests the undersigned Team to move up or down a division and is agreed upon by the Team. The undersigned Team hereby agrees upon the terms and conditions contained in this Agreement. The Team agrees that it will adhere to all NCBA rules and regulations of their respective division (DI, DII, or DIII), including, but not limited to, the payment of the NCBA 2025/2026 annual dues of their respective division (DI, DII, or DIII) in the amount of \$2,205.00 (DI), \$1,945.00 (DII), \$1,730.00 (DIII) which shall be due and payable no later than February 28, 2026. Annual dues for the 2025/2026 season shall be discounted to \$2,105.00 (DI), \$1,845.00 (DII), \$1,630.00 (DIII) if paid in full by the Team on or before December 1, 2025. The Team understands that the annual dues are non-refundable. The Team further understands and agrees that all accounts or monies due to NCBA shall be paid in accordance with the Credit Terms stated above, and agrees to pay all reasonable cost of collection, in addition to any court cost and/or attorney fees incurred in collection.

**\*The team also agrees that it will submit a performance bond to the NCBA prior to Sept 15, 2025. The performance bond is \$600.00 for DI Teams, \$300.00 for DII Teams, and \$0.00 for DIII Teams.** This performance bond will be returned to the team in full at the conclusion of the 2025/2026 season provided the team has not forfeited any of its NCBA Sanctioned games. (See NCBA DI Rule 24.06.0, NCBA DII Rule 24.06.0).

The Team further understands that it is responsible for ensuring that all team players individually complete the online NCBA Player Registration for their respective division (DI, DII, DIII), and agrees to submit a signed academic eligibility letter for all team players to the NCBA prior to participating in any NCBA sanctioned baseball games.

In consideration of the Team’s agreement to be bound by the terms of this League Participation Agreement and the NCBA rules and regulations of the Team’s respective division (DI, DII, DIII), the NCBA hereby agrees to provide the following benefits and services throughout the term of the NCBA 2025/2026 season:

- 1) Official recognition as a member of the National Club Baseball Association;
- 2) Scheduling of a regular season conference schedule of games;
- 3) Opportunity to compete for the right to participate in National Postseason play;
- 4) Full access to the Official NCBA website ([www.clubbaseball.org](http://www.clubbaseball.org), [www.div2.clubbaseball.org](http://www.div2.clubbaseball.org) & [www.div3.clubbaseball.org](http://www.div3.clubbaseball.org)) for the purpose of tracking rosters, player stats, player bios, team records, conference standings, team website access, and team contact information;
- 5) Pre-paid delivery of Official NCBA game balls; 6 dozen for NCBA Division I teams, 5 dozen for NCBA Division II & III teams;
- 6) Pre-paid delivery of 1 BBCOR Certified Baseball Bat; All NCBA Divisions;
- 7) Pre-paid delivery of 8 Batting Helmets OR 1 complete set of Catchers Gear; NCBA Division I & II teams only;
- 8) Team coverage under an NCBA premium pre-paid general liability insurance policy;
- 9) Participation in the benefits of all Official NCBA Sponsorship & Fundraising programs and
- 10) Opportunity to obtain Official NCBA Consultation on club baseball program management and marketing plans.

**\*Performance bond due ONLY if the 2024-25 performance bond was returned or forfeited.**
